### SECTION 1: GENERAL CONSENT

I, the undersigned applicant, hereby voluntarily and knowingly give my **informed consent** to **Pota EasyMoney Solutions** (“EasyMoney”), and its affiliated platforms (including **Future Campus**) to:

1. **Collect, process, evaluate, and manage** my loan application using the personal, academic (if applicable), and financial information I have provided.
2. **Collect my data solely for the purposes related to the assessment, disbursement, monitoring, and repayment** of a loan facility. No unrelated use will be permitted without further consent.

6. **Provide me with the right to access, review, and request correction or updating** of any personal or financial data stored by EasyMoney during the life of the loan and during the retention period. Requests can be made in writing or via our digital platforms.
7. **Disclose to me in advance** if my personal information must be shared with any external third-party partner or service provider. Such sharing will only occur under secure, contractual agreements.

I understand and acknowledge that:

- I am **legally responsible** for repaying any loan granted under this application in accordance with EasyMoney's repayment terms.

    - I may incur additional fees, interest, and penalties.
